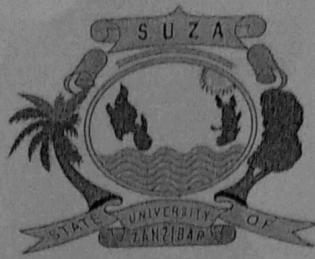

**RESOLUTION OF REGISTRATION OF CONSTITUTION IN THE NATIONAL
REGISTRY OF ASSOCIATIONS**

With this date, the following resolution has been issued by this Ministry:

"Regarding the application for registration in the National Register of Associations made by Mr. Alvaro Lorenzo Maldonado, on behalf of and in representation of the entity called **KUKUA**, at C / MAURICIO LEGENDRE N° 1 - 3° - PTA. 231, Postal Code 28046, MADRID, is resolved as following:

BACKGROUND

FIRST. The application for registration in the national register of associations has been presented for the aforementioned entity. Attached to the application is the association's Founding Act recorded 09/10/2017 and the corresponding Statutes, which include objectives and indentifies the scope of action located in territory within and outside the State.

SECOND. The procedure has been instructed in accordance with Law 39/2015, of October 1 on the common administrative procedure of Public Administrations, and in accordance with the provisions of the specific regulations governing the right of association.

LEGAL GROUNDING

FIRST. Article 22 of the Constitution and Organic Law 1/2002, of March 22 recognizes and regulates the fundamental right of association, and establishes that nonprofit associative entities shall register in the corresponding public registry, for the sole purposes of publicity.

SECOND. Chapter V of the Organic Law 1/2002, of March 22 regulating the right of association, and articles 42 and 43 of the regulations of the National Registry of Associations, approved by Royal Decree 949/2015, of October 23 establish the substantive requirements and

formal nature that these types of entities must comply with in order to be registered, provided that they are not found in cases of article 22.2 and 5 of the constitution.

In application of this regulation, and once examined the documentation that appears in the file, it is verified that the applicant entity meets all the necessary requirements to proceed to its registration in the National Registry of Associations.

THIRD. The competence to resolve the procedure corresponds to the General Technical Secretariat, as it is the result of article 39 of the Regulation of the National Registry of Associations, and of article 8.2.I) of Royal Decree 770/2017, of July 28 by which the basic organic structure of the Ministry of the Interior is developed.

In virtue of the above, and in use of the faculties that have been attributed to it, this Technical General Secretariat

RESOLVES

the inscription of **KUKUA** entity and deposits the mandatory documentation in the National Registry of Associations, for the sole purpose of publicity, and without this supposes exoneration of the fulfillment of the regulatory legality in force of the necessary activities for the development of its aims.

Against this resolution, which does not end the administrative process, an appeal may be filed with the Assistant Secretary of the Interior within a period of one month counting from the day following this notification, in accordance with the provisions of article 41 of the Regulations of the Registry National of Associations, approved by Royal Decree 949/2015, of October 23 and in articles 121 and 122 of Law 39/2015, of October 1 of the common administrative procedure of the Public Administrations. "
